# Learnings from the DEIB Workshop Series: San Francisco Village

On February 22, six leaders of San Francisco Village shared their journey towards growing a village that reflects the demographics of their service area. Their brave and vulnerable story created an opportunity for the audience to go deep. Here are highlights from their presentation along

### The Groundwork

Events during the Spring and Summer of 2020 spurred San Francisco Village to begin its DEIB journey. The COVID 19 lockdown and daily deaths, the murder of George Floyd and the nationwide protests, wildfires and toxic air that made it dangerous to go outside—collective trauma—led to critical self-reflection and the hiring of a DEI Consultant, <u>b\*free</u>. Work with **b\*free** drove personal and systemic analysis and followup work. A focus was unpacking white dominant culture. Staff and board discovered that brave conversations feed the potential for change.

## The Big Picture – The Strategic Plan

The work with **b\*free** led to a new five-year strategic plan that reaffirms the village's commitment to connecting older San Franciscans to the community, resources, and expertise they need to navigate the transitions of aging in a changing world. It makes explicit the commitment to equity: a bigger vision that includes people of all ages, races, cultures, and abilities working together to create a community of belonging, and in so doing, demonstrate possibilities for relationship and connection that benefit the greater good.

#### What strategies are in your village's foundational documents?

#### The People

Staff and board members engaged in deep reflection and planning with **b\*free**. This led to invitations to village and community members to join together in learning, planning, and taking action. San Francisco Village reached outside the organization for help with introductions to Black organizations, and for coaching. They are sharing their Strategic Plan widely with community members, funders, and local policymakers.

## Who are the people in your village and partner organizations who are taking meaningful action to further DEIB?

## The Approach

Village leaders went out to the community to listen and learn, not preach and teach. Questions they asked were, "What is your experience?" and "How can we be of service?" They learned about the IT Bookman Center, an African American organization in an isolated part of San Francisco, and initiated community listening sessions.

The village brought money to the endeavor and hired an African American partner to introduce them to Black community leaders in Bayview-Hunters Point, a predominantly Black neighborhood. They also introduced Carlene Davis, SAGE Sistahs Co-Founder, along with grant funding, to the Village's partnership with the IT Bookman Center. Carlene will lead an in-depth process to bring the two organizations together.

What organizations are out there for your village to discover and contribute to? How might you channel resources, including funding, to them?

## Accessibility

Several years ago, San Francisco Village adopted tiered dues to include older adults of different income levels. They plan to conduct further analysis of their data to learn more about their members so they can expand accessibility.

Village leaders address micro-aggressions as they occur in order to create and maintain an open, safe space for people of many backgrounds. Micro-aggressions are statements and behaviors that cause harm to BIPOC (Black, Indigenous, People of Color) and LGBTQ (Lesbian, Gay, Bisexual, Transgender, Queer) people. They are often casually made without harmful intent but create uncomfortable and even dangerous environments. Addressing micro-aggressions when they occur creates an atmosphere of trust and belonging.

# How can your village be made more accessible to the communities you want to attract?

#### Indicators of Change

Village membership has increased by 35% to 500 members at a rate of 12-15 new members per month. .Membership among Blacks increased by 4%, Asian and Asian Americans increased by 3%, LGBTQ older adults by 12-13%. There are over 200 multi-generational volunteers. Staff reflect the demographics of San Francisco.

The weekly bulletin, monthly newsletter, website and social media, the programs being offered, the teachers selected, and programs initiated by members explicitly include BIPOC and LGBTQ teachers, leaders, and organizations. The village continues to build intergenerational programming and Board leadership.

## **Medicare Fraud Prevention**

Even when you do everything right, there is a chance that you could be a target of fraud. Detect fraud by examining both the *Medicare Summary Notice (MSN)* you receive from Medicare after your claims are paid, and/or the *Explanation of Benefits (EOB)* you receive from your Part C and/or Part D

plan.

You can also view your MSNs online by accessing your Medicare account at <u>Medicare.gov</u>. If you don't have an account, then set one up so that you can stay in control of your benefits. Here's what to check for:

- Did you receive all the services/prescriptions listed?
- Were you billed for something you didn't get?
- Did your doctor order these services?

- Do the prescriptions listed match the prescriptions you received?
- Were you billed for the same thing twice?
- Are the dates of the services/prescriptions, correct?
- Are the dollar amounts shown the same as those on your bill?

If you suspect something's wrong, report it!

- Call the health care provider listed on the *Medicare Summary Notice* or *Explanation of Benefits* and inquire about the questionable item(s). In many cases, it may be the result of a billing error, which can easily be corrected.
- If your question is not resolved and you still think the charges are fraudulent, call <u>Senior Medicare Patrol</u>: 1-855-613-7080.
- You can also contact the U.S. Department of Health and Human Services' <u>Office</u> <u>of Inspector General</u>: 1-800-447-8477. Your SMP counselor will help you determine if this step is necessary.

Have your Medicare Summary Notice and/or Part D Explanation of Benefits ready when you call.

Your local HICAP (Health Insurance Counseling and Advocacy Program) provides free education and counseling. Medicare is a complicated benefit, and your HICAP program can help you navigate it.

This seminar, hosted by Village Sonoma Valley, will help you recognize a fraud scheme right when it is happening and teach you how to protect yourself on the phone, on the internet, and by mail.
